## I. General provisions

1. The \$40 No Deposit Bonus (hereinafter the 'No Deposit Bonus', 'Bonus', the 'Bonus funds') is a special trading credit provided by the Company.
2. The Bonus is given for trading purposes only and cannot be withdrawn.
3. By applying for the Bonus the Customer confirms that they have read and accepted these terms and conditions and will not send any claims to the Company regarding terms of bonus use or measures undertaken by the Company in accordance with these Terms and Conditions.

## II. Conditions of eligibility

1. Subject to, and in accordance with all other Business Terms and Policies, the offer is available to Amega customers who have satisfied the eligibility criteria for the offer (hereinafter 'Eligible Customers').
4. Eligible Customers are those who have registered with Amega after September the 9th 2021, and who have fully verified their profiles.
5. The Bonus can only be applied to one account per Customer.
6. Participation of Intermediaries/related parties such as family members is prohibited.
7. Bonuses cannot be transferred between accounts,
8. Amega offers the No Deposit Bonus promotion in any countries/regions as it deems appropriate for the duration of the promotion, as determined by Amega..
9. Countries/regions not eligible for the No Deposit Bonus promotion: Indonesia and Bangladesh.
10. In order to receive the Bonus the Eligible Customer needs to:
  - a) verify their profile
  - b) open a Standard Promo MT5 account
  - c) activate the promo code **JOINAMEGA**

## III. Specific No Deposit Bonus terms

1. Eligible Customers, who met the criteria forth herein are able to receive the bonus equal to 40 USD of Bonus funds.

2. The leverage on the Promo MT5 account, to which the \$40 No Deposit Bonus is credited, is 1:100
  3. Bonus funds are available for trading for 30 days after the promo code is activated.
  4. The Bonus funds belong to the Company.
  5. The Customer and the Company has the right to cancel the Bonus at any time.

## IV. Restrictions. Bonus cancellation

1. There are some other types of bonuses the Company provides to its Customers. Different types of bonuses cannot be mixed together in the same trading account. In order to receive other types of bonuses the Customer needs to open different trading accounts.
2. Opening of opposing (hedged) positions using the same or similar trading instruments on different trading accounts with the Bonus funds at the same time is prohibited.
3. Since the Bonus funds belong to the Company, the Company has the right to:
  - cancel (debit) the Bonus from the trading account without prior notice and without giving any reasons to the Customer.
  - refuse to provide the Bonus for the Customer without giving any reasons; and
4. Company has the right to change the present Terms and Conditions or terminate the No Deposit Bonus promotion at any time without prior notice.
