1. Terms and Definitions

- 1.1. The "Company" is AMEGA Forex Broker.
- 1.2. The "Promotion" is the promotional Amega BOOM offer which is held in accordance with the terms below.
- 1.3. A "Customer" is a customer of the Company who has completed full verification of their account.
- 1.4. A "Participant" is a customer who has successfully registered for the Promotion.
- 1.5. The "Referral Link" is the link leading to the Company's website which contains the unique Customer identifier.
- 1.6. An "Affiliate Code" is a unique set of eight characters, which is part of the mechanism by which Customers introduced to the Company by an Affiliate can be identified.
- 1.7. "Registration" is the registration process for the Promotion which allows a Customer to become a Participant.
- 1.8. A "Referred Participant" is a Customer who has become a Participant in the Promotion by invitation from another Participant.
- 1.9. A "Bonus Account" is a Premium Promo MT5 trading account in USD with a leverage of 1:100, and is registered for the Promotion and owned by a Participant.
- 1.10. The "Bonus" is a cash reward which is credited to the Bonus Account as credited funds. Bonuses can be credited to the Bonus Account multiple times.
- 1.11. A "Deposit-free Welcome Bonus" is funds which are credited to a Customer's trading account for a certain promotional offer.

2. General Provisions

- 2.1. Every Customer has the right to take part in the Promotion.

- 2.2. The start date of the promotion is April 24, 2019. The promotion is available for an indefinite period of time until the Company cancels it.

3.How do I get Bonuses?

- 3.1. The maximum bonus amount that a Customer can receive in the Promotion in total is \$1,000.
- 3.2. Participants are required to use their Referral Link or Affiliate Code to refer other participants to the Promotion. Participants can get a \$10 Bonus for each Referred Participant only if the Referred Participant has registered with the Company no earlier than at the start of the Promotion by using the Referral Link or Affiliate Code of the Participant in the registration form on the company's website and has received a \$15 bonus to their Bonus Account.
- 3.3. Bonuses are credited to the Bonus Account.
- 3.4. Bonuses must be used within 90 days of being credited to the Bonus Account.

4.Registration and Participation in the Promotion

- 4.1. How do I register for the Promotion?
 - 4.1.1. Become a Customer.
 - 4.1.2. Open a Premium Promo MT5 trading account in My account; and
 - 4.1.3. Select the trading account required for participation and click "Take part" in the special form on the Promotion page.
 - 4.1.4. The initial \$15 Bonus can be credited to the Customer's Bonus Account once they have successfully registered, provided that the Customer has not previously received any Deposit-free Welcome Bonuses.
- 4.2. After registering for the Promotion:

- 4.2.1. Cash flow on the Bonus Account is blocked and the leverage is limited to 1:100 for the whole duration of the Promotion.
- 4.2.2. Customers can attract other Participants from all over the world using all available means by quoting their Referral Link or Affiliate Code.
- 4.2.3. For each Referred Participant, a \$10 Bonus is credited to the Participant's Bonus Account.
- 4.2.4. Participants must make trades using the Bonus Account and must have at least 15 closed positions after 30 days from the moment the first Bonus is credited to the Bonus Account.
- 4.2.5. If the conditions described in Paragraph 4.2.4 of these Terms and Conditions are not met, the Participant will be excluded from the Promotion and all Bonuses will be removed from the Bonus Account. Any profits on the Bonus Account received during the Promotion will remain available for withdrawal or trading outside of the Promotion.
- 4.2.6. If the conditions described in Paragraph 4.2.4 of these Terms and Conditions are met successfully, the cash flow block is removed from the Bonus Account and the Participant can withdraw trading profits in any amount without restrictions, whilst taking part in the Promotion at the same time.
- 4.2.7. Bonuses are removed from the Bonus Account in their entirety and the Participant is excluded from the Promotion 90 days from the moment the first Bonus is credited. All profits on the Bonus Account received during the Promotion remain available for withdrawal or for further trading outside of the Promotion.
